Course Title: Basic Operations and Advanced Technician Firefighter Blended

Course Duration: 260 hours

Program: Fire Fighting

Course Prerequisites: None

Required for National Certification (ProBoard/IFSAC): Hazardous Materials Operations

Course Description:

The Basic Operations and Advanced Technician Firefighter Blended (BOF) program balances instructor-supported online training with in-person weekend course activities. In-person, practical class activities are completed at remote training sites located throughout Illinois. The program incorporates practical training activities with a comprehensive academic curriculum designed to prepare entry-level firefighters for the demands of the profession. This course exceeds the requirements outlined by the Illinois Office of the State Fire Marshal for Basic Operations and Advanced Technician Firefighter training. Upon successful completion, the students will meet Illinois OSFM, ProBoard, and IFSAC NFPA 1010 Firefighter I and Firefighter II requirements for certification.

How the Course Works:

Each week's content will be delivered online. Students will be required to complete a series of activities for each lesson which will include a reading assignment, Virtual Learning Session (VLS), and a weekly quiz. The student can expect to spend approximately five (5) hours each week on this course plus sixteen (16) hours on practical sessions every other weekend.

Mandatory In-Person Orientation – Saturday, January 10th, 2026

PPE (including SCBA and one spare bottle) is required at this session for inspection by IFSI staff. PPE must be within its NFPA 10-year life expectancy. All bottles must be marked with a valid hydrostatic test date (within the last five years). Students should bring the laptop or tablet they will be using for the online portion of the course.

The orientation will be hosted at each regional training site and will introduce students to the instructors and provide an overview of the 18-week program. Instructors will also confirm each student's access to the Learning Management System.

Course Schedule:

Each week begins on **Saturday at 12:01 AM** and assignments are due by **11:59 PM the following Friday**. Students are expected to keep up with each week's assignments.

The schedule is in the first topic section of the course. The schedule may change as the class progresses or may not follow the subject areas listed. Students should look for changes or updates in the *Announcements* forum in the first topic section.

Required Textbook:

Fundamentals of Firefighter Skills, 5th Edition, Jones and Bartlett Learning

The textbook is provided to the student during orientation.

Weekly Reading Assignments:

Each week, students will be assigned chapters to read and review from the provided textbook. These assignments will prepare the students for the content of the Virtual Learning Sessions and the Weekly Quizzes.

Virtual Learning Sessions (VLS):

Each week an instructor will conduct two Virtual Learning Sessions. Sessions are scheduled on Monday and Tuesday evenings from 7:00-9:00 PM. **Students only need to attend one of the sessions.** These sessions are mandatory. The instructor will use these sessions to convey critical elements of each subject, and students can ask questions about the subject material. Student attendance and participation will be recorded as a grade. Students must achieve a score of 75.00 or higher to successfully complete each session.

VLS Make-up Assignment:

Virtual Learning Sessions are a required part of this course. If the student misses both live weekly Virtual Learning Sessions or does not achieve a passing score of 75.00 or higher, he/she must make up that session.

To make up a Virtual Learning Session, the student will navigate to the Online VLS Library and select the archived session that he/she missed. The student will open the VLS Makeup Assignment, watch the entire recorded VLS, and write a four-paragraph summary of what the instructor discussed. This assignment must achieve a score of 75.00 or above and is due by the weekly Friday deadline.

Weekly Quizzes:

Each week, students must complete an untimed quiz at the end of each lesson. Students must achieve 75% or higher. Students may take the quiz more than once. The learning management system will record the highest score achieved. Each quiz will prepare the student for the final state certification exam. Weekly quizzes must be completed before the Friday deadline.

Term Quizzes:

At designated points throughout the program, students will complete term quizzes. These quizzes will consist of random questions selected from multiple previously covered chapters. Students must achieve 75% or higher. The quiz schedule is as follows:

NIMS 100, 200, and 700

Upon completion of these courses, students will upload copies of the completion certificates to the online classroom.

Opioid Awareness

This course ensures students gain the ability to identify the signs and symptoms of substance abuse, particularly opioids, and a familiarity with applicable resources to manage such situations. **Prior certificates of an equivalent course will not be accepted. All students must complete this course as part of this program.** Completion of this module will automatically be recorded in the online classroom within one week.

Resiliency Awareness

This course ensures students gain familiarity with the signs and symptoms of mental illness, mental health and resiliency, and applicable resources to manage such situations. **Prior certificates of an equivalent course will not be accepted. All students must complete this course as part of this program.** Completion of this module will automatically be recorded in the online classroom within one week.

Traffic Incident Management System (TIMS) Awareness

This course meets the requirements for the completion of Traffic Incident Management (NFPA 1091) training. **Prior certificates of an equivalent course will not be accepted. All students must complete this course as part of this program.** Completion of this module will automatically be recorded in the online classroom within one week.

Fire Service Vehicle Operator (FSVO)

This online module satisfies OSFM's JCAR Section 141.370. **Prior certificates of an equivalent course will not be accepted. All students must complete this course as part of this program.** Completion of this module will automatically be recorded in the online classroom within one week. **Students do not need to schedule an exam at the completion of this course.** The exam will be provided during a practical weekend. After IFSI's course completion, the student is required to complete the following with his/her sponsoring fire department:

- Completion of the required NFPA 1010 competency course
- Completion of an additional 8 hours of documented driving of vehicles with differing wheelbases in use by the employing authority having jurisdiction

Practical Weekends:

There are ten practical weekends. The practical weekends will consist of two approximately eight-hour days (Saturday and Sunday) beginning at 8:00 AM. **Attendance is required at every practical weekend.**

Written Examinations:

Once students have completed all subject areas and passed the subject area quizzes, they will be eligible to take the in-person written examinations during the following practical weekends:

- FSVO - Practical Weekend 8
- BOF - Practical Weekend 9
- ATF - Practical Weekend 10

Evaluation Strategy:

State and national certifications require completing all the online coursework, passing the module quizzes, completing the hands-on practical activities, and passing the written examinations.

Course Policies:

Attendance Policy: IFSI requires students to attend (100%) or make up all course content that leads to certification. Students are expected to arrive on time and to remain in class for the duration of the course. Students **MUST COMPLETE** all portions of these certification courses, both classroom and practical, to be eligible to receive certifications.

If a student misses any portion of class with an accumulated absence of 10% or less of scheduled class time, it will be the student's responsibility to arrange the make-up of the missed course content with the instructor(s) or program manager. The student must make up the specific course content that he or she missed, not just the hours. Make-ups are limited to 10% of scheduled class time.

Make-ups must be documented on the class roster. If a student's absence is greater than 10% refer to the "True Emergencies" section of the IFSI Examination Policy.

A student may not miss more than a combined 16 hours of practical skills.

No Call/No Show Policy: Any student that fails to attend a practical session at the scheduled time without making prior arrangements with the site lead may face removal from the program. All tardies and/or absences must be communicated before the scheduled start time of the practical session.

Safety Policy: Students shall understand and follow all instructions pertaining to operational safety, as stated by instructors, or as written in course materials. Instructors and students should always be mindful of safety. Conduct judged to be unsafe shall be grounds for dismissal from the course.

Academic Integrity Policy: IFSI has the responsibility for maintaining academic integrity to protect the quality of the education provided through its courses, and to protect those who depend upon our integrity. It is the responsibility of the student to refrain from infractions of academic integrity, from conduct that may lead to suspicion of such infractions, and from conduct that aids others in such infractions. Any violation of the code of conduct is grounds for immediate dismissal from the course.

Late/Incomplete Assignment Policy: Students are expected to successfully complete all assignments and quizzes by the assigned deadlines. A student may not exceed five (5) late/incomplete submissions throughout the delivery.

Grading Policy: Decisions regarding certificates of course completion shall be made solely by the Program Director of the course. All grading of exams shall be conducted by the Curriculum, Testing, and Certification (CTC) Office. All grading of practical exercises shall be based upon the standards set by the regulatory agency referenced in the course material and IFSI.

Retesting: If a student fails to pass an exam, retesting takes place on set dates at regional sites across the state. More information is provided in the course completion email and on the IFSI website.

American Disabilities Act: As guaranteed in the Vocational Rehabilitation Act and the American Disabilities Act, if any student needs special accommodations, they are to notify their instructor and provide documentation as soon as possible so arrangements can be made to provide for the student's needs. If arrangements cannot be made at the class site, the student will test at an alternative time and place where the special accommodation(s) can be made.
