HANDS-ON COURSE PARTICIPATION GUIDELINES:

SCBA: SCBA must be NFPA compliant and in working order. Only SCBA with current hydrostatic dated cylinders will be allowed. Students must provide their own equipment. No sharing is allowed. Loaner equipment and repair services will not be available.

FACIAL HAIR: Facial hair that crosses the jaw line is not permitted in courses where breathing apparatus will be used. **No exceptions.**

AGE: Students must be 18 years of age or older and a member of a fire department in order to participate in the hands-on training.

CONSUMPTION OF ALCOHOL OR ILLEGAL DRUGS: Any indication of the consumption of alcohol or illegal drugs by participants during any hands-on training will result in denial from the program. Instructors will have full discretion to enforce this policy.

FOUNDATIONS OF FIREFIGHTING

The Foundations of Firefighting Course was developed for new firefighters. The class is designed to safely place you on the working fire grounds. The course will cover the usage of self-contained breathing apparatus (SCBA), line advancement, ventilation and basic fire ground operations. Material covered will result in your safety as an effective firefighter for your department.

NFPA compliant personal protective equipment and SCBA is required.

ESSENTIAL SKILLS FOR FIREFIGHTING

The Essential Skills for Firefighting Course incorporates multiple training topics into one convenient schedule. Class topics include forcible entry, RIT training and thermal imaging camera applications. Students will participate in hands-on drills with both inward and outward swinging doors as well as multiple types of tools and locks. Live fire scenarios will address the tactical and strategic operations related to downed firefighters and the operation of the thermal imaging camera. **NFPA compliant personal protective equipment, SCBA, and ear protection is required.**

ENGINE COMPANY OPERATIONS – LONG LEAD OUTS

The Engine Company Operations – Long Lead Outs Course provides the opportunity to hone your skills at making the long stretch. When your preconnected hose line is not going to reach, what is your plan, is it the most efficient method, have you and your crew trained and drilled on making the long leadout? This class allows repeated opportunities to manufacture lines off the rear hose bed to reach the tactical objective. Increasing your proficiency at building lines will result in getting water on the fire as quick as possible. **NFPA compliant personal protective equipment and SCBA is required.**

AGRICULTURE RESCUE TECHNIQUES

The Agriculture Rescue Techniques course will teach first responders and rescue personnel the principles and guidelines for safe response to agriculture related incidents. Subject matter covered includes tractor rollovers, grain auger entrapments, farm machinery entrapments, emergencies related electrical malfunctions, and chemical exposure incidents. Confined space and how it relates to incidents that involve manure pits and grain bins will be covered as well. Students will learn extraction methods, machinery stabilization, lock out/tag out of hazardous systems, patient assessment, and packaging. Preplanning along with site visits will be encouraged with local farmers, agriculture machinery dealerships, repair shops, and commercial chemical dealerships.

Required equipment/gear: Turn out gear or coveralls, helmet, gloves, eye protection, ear protection, steel toed shoes.

THERMAL IMAGING CAMERA: APPLICATION FOR SEARCH AND RIT OPERATIONS

The Thermal Imaging Camera: Applications for Search and RIT Operations course provides in-depth training on the use of thermal imaging cameras on response scenes. Class topics include basic camera function, search techniques, fire behavior, and RIT operations. Students will engage in multiple live fire training scenarios that will connect the usage of the fireground tool to primary and secondary search techniques, RIT operations, and victim removal using webbing. This new course will challenge all skill levels.

NFPA compliant personal protective equipment and SCBA is required.

CERTIFICATION COURSE:

TACTICAL EMERGENCY CASUALTY CARE/ RESCUE TASK FORCE TRAINING

16 HOURS | FRIDAY, 1PM-5PM & SATURDAY, 8AM-5PM & SUNDAY, 8AM-12PM

The Tactical Emergency Casualty Care/Rescue Task Force Training (TECC/RTF) Course is an EMS-based class designed for all skill levels. The class covers topics that decrease preventable deaths from active shooter, hostile, or mass casualty events. The TECC program includes discussions, table top, and full immersion exercises. Upon successful completion of the course, students will receive TECC certification from the National Association of Emergency Medical Technicians (NAEMT).

MYTHS & REALITIES: FOG NOZZLE VS. SMOOTH BORE NOZZLE

The Myths and Realities: Fog Nozzle vs Smooth Bore Nozzle class will focus on one of the most historic debates in the fire service. Instructors will address the use of the fog nozzle or the smooth bore nozzle during fire attack, the benefits of specific usage, and safety measure comparisons. The course will explore different hose stream selection for the fire attack and the pros and cons of each choice.

IFA FREE LODGING REQUIREMENTS:

Conference attendees may receive up to 3 nights of hotel accommodations for FREE*. The Illinois Firefighter's Association (IFA) has received a grant from the Office of the State Fire Marshal to cover a portion of the hotel rooms for the annual Down & Dirty Conference. Rooms in the IFA/IFSI block are limited and available to registrants on a first-come, first-served basis.

The details:

- The IFA will pay for hotel room and hotel room taxes only.
- Registrants may reserve rooms only after registering for the conference AND must attend all training, for the room expenses to be covered by IFA.
- One person per room is preferred.
- Rooms must be booked in the attendees' name and a personal credit card is required to cover incidental expenses.
- Thursday night accommodations will only be covered for registrants who attend the annual meeting on Friday morning.
- Friday night accommodations will only be covered for registrants who attend the Friday afternoon session and/or Saturday sessions.
- Saturday night accommodations will only be covered for registrants who attend all Saturday sessions.
- Must mention the IFA/IFSI block to receive the accommodation.

COVID-19 SAFETY PRECAUTIONS & PROCEDURES

The safety, health, and wellbeing of our students, instructors, conference attendees and staff is at the forefront of concern when planning for any training event. Due to COVID-19, the following protocols will be enforced during the Down and Dirty Firefighting Weekend.

- Any student, instructor, conference attendee or staff member should stay home and contact your health care provider immediately, if you have any of these symptoms: fever, scratchy throat, shortness of breath, chest pain, unexplained chills, repeated shaking with chills, sudden muscle pain unrelated to exercise, headache, or a loss of taste or smell.
- All students, conference attendees and staff will be required to complete a health screening each day while attending IFA activities. This screening will include the completion of a brief COVID-19 specific health questionnaire and temperature evaluation. There are no exceptions to this policy.
- Students, conference attendees and staff will be required to wear a face covering except when:
 - A person is alone in their office, classroom, restroom, or vehicle.
 - o A person is indoors and able to maintain 6-feet social distance between individuals.
 - o A person is outdoors or in an open air environment and able to maintain an appropriate distance of 6-feet between individuals.
 - A person is donned in appropriate personal protective equipment for training purposes.
- All students, conference attendees and staff will be required to comply with the following standardized IFSI health and safety protocols, to include:
 - Maintain 6-foot social distancing when possible.
 - o Wash your hands regularly. Hand washing stations will be available indoors and on the training grounds.
- · All IFA conference participants (students, vendors, and attendees) must provide their own face coverings.
